PARTIES INVOLVED: This contract is being made between the Barberton Area Jaycees and the above named contact person, on behalf of the above named organization.

DATE, TIME & COST: The Exhibitor is requesting permission of the Barberton Area Jaycees to occupy the Community Tent space of the exhibitors' area at the Cherry Blossom Festival during ONE of the following times at no cost to the Exhibitor. Please indicate your first and second choice with a 1 and 2. If approved, you will only be given one time slot.

LOCATION: Visitors Center Grounds of Lake Anna Park, 535 W Park Ave, Barberton. Two booths will be set up along the Park Ave sidewalk with a Community Tent sign on it. You may occupy whichever table is vacant when you arrive at your scheduled time.

FIRST COME, FIRST SERVE: The Exhibitor understands that space is limited and spots will be filled on a first come, first serve basis. If the spot you choose has already been taken, another space will be offered for you.

PRODUCTS: The Exhibitor agrees to only sell the items listed above. All items must meet the Barberton Area Jaycees product criteria. Items must be new, clean and family friendly. Items must not contain the advertisement of drugs, smoking, alcohol, foul language, weapons, etc. Items can not compete with the Kissel Bros Show Inc, such as food, drinks or carnival-style games. Items also cannot compete with the products of a paid Exhibitor vendor, such as face painting and sand art.

NO SALES OUTSIDE BOOTH: The Exhibitor agrees to use only the booth designated as 'Community Tent' and further understands that no sales can be made, nor literature passed out beyond their space.

PARKING: The Exhibitor agrees to obey all parking rules set forth by the City of Barberton and the Barberton Area Jaycees. Cars are not permitted in the Festival area, including parts of Third Street and Park Avenue as well as the Lake Anna Park service paths.

SET UP: The Barberton Area Jaycees will provide a 10'x10' tent, 8 ft table, 2 chairs, fire extinguisher, extension cord and electric at a space on the Visitor Center grounds of Lake Anna Park. The Exhibitor agrees to do their best to set up their products prior to start time. Be aware of the limited access on Saturday morning due to the 10AM parade. The Exhibitor understands that their booth must not be left unattended.

DAMAGE: The Exhibitor agrees to leave the premises in as good condition as it was before this agreement was made. No damage will be made to Barberton Area Jaycee property, grounds, trees or surroundings of Lake Anna Park.

LIABILITY: The Exhibitor agrees to assume all risks, loss, damage or injury to self, volunteers, merchandise and property. The Exhibitor further agrees not to hold the Barberton Area Jaycees, City of Barberton, Kissel Bros Shows Inc, volunteers or any affiliate liable for any claims, demands, expenses, fees, fines, penalties, suits, proceedings or any other kind of action arising in any way connected with the Cherry Blossom Festival.

CONFIRMATION: The Barberton Area Jaycees reserve the right to accept or deny any application. The Exhibitor will be contacted as soon as possible with the date and time available.

Failure to meet all above agreements and rules set by the Barberton Area Jaycees will result in removal of the Exhibitor from this event and prevent future participation.
